Motion by Mary Weimer, seconded by Laura Oldt, to accept the bid for sandblasting and finishing of the basement registers for \$561.00. Motion passed unanimously by roll call vote.

The director requested that Frank Werschem's portrait be placed back on the basement wall.

Motion by Laura Oldt, seconded by Donna Pope, to present a tentative draft agreement with Spring Lake regarding a reciiprocal agreement allowing Fruitport to issue Spring Lake Library cards to patrons from that district and to allow those patrons to pick up holds at Fruitport.

Motion by Laura Oldt, seconded by Mary Weimer to approve the air conditioning bid from Jewitt Heating for \$615.00.
